

Regeneration update

We have been watching the progress of the Foxhill Regeneration outline planning application through Bath & North East Somerset Council Cabinet and the referral to Central Government where it was considered. It is now subject to a judicial review process and we await the outcome. In the meantime, Curo will be continuing to develop detailed plans for the Bradford Park area (Phase 1) in consultation with local residents. We will be providing intensive support throughout this process, making sure you are kept well informed, supported and fully aware of your rights, options and any implications that may affect you. We will be offering specialist sessions about particular options worrying people, concerns about rehousing; home loss, financial help and support. These legal rights affect different types of residents in different ways and we are here to help you.
