Agreed to reconcile member numbers every 6 months based on attendance at meetings and engagement with NETV activities.

Agreed a finance update to be given every 3 months at the meeting.

Action: Tpas to re-send Zoom Groundrules.

#### 4. Review Paper

Tpas to re-propose their services going forward with a pick and mix approach. NETV to discuss and decide on Tpas' involvement with the group at the next NETV meeting. Tpas will leave the meeting so open discussion can take place.
